# Terms and Conditions



- 1) A 15% buyer's premium is added to all winning final bids. All items must be paid in full on the day of the sale. No purchase may be removed until paid in full.
- 2) Bidding will start on 9/28/23 and end on 10/8/23 starting at 1:00 PM with each lot closing 2 minutes apart. If there is any activity within the last two minutes of any one lot, an additional minutes will automatically be added to that lot.
- 3) Proxy Bidding is allowed and must be submitted online only.
- 4) Many items will have no reserve. For the lots that do have reserves, those reserve prices will only be revealed if not met and will be placed in the Estate Sale at the reserve price.
- Example, Lot #1 has a reserve of \$ 3,000,00. The highest bid is \$ 2,000.00, but a proxy bid was just submitted at \$ 4,000.00. The reserve bid has been met at \$ 3,000.00, the next bid would be at \$ 3,250.00. Any bid that is higher than \$ 3,250.00 will automatically be met and raised by \$ 250.00 until the limits of the proxy bid of \$ 4,000.00.
- Example. if there is a tie between two proxy bids, the bidder who placed the proxy bid first will have the lead.
- Example, lot #2 has a bid of \$ 1,000.00. Two proxy bids come in at \$1,500.00 and \$ 2,000.00. The bidding is automatically raised to \$ 1,600.00 by the proxy bid. (The bidder who bid \$2,000.00 only pays 100.00 over the next closest bid and not the full \$2,000,00)

# Form of Payment

All payments must be made by cash, bank wire, credit card, Venmo, or money order. Or have your credit card on file to be charged for all sales, and any other incidental costs you incur, in the event cash, Venmo, or acceptable payment is not available. If paid with credit card, a 3% fee will be applied. If shipped out of state, no sales tax will be charged.

### **Bidding Increments**

The On-line Auction is programmed to accept bids in the following increments:

Up to \$2,500.00 - bids of \$100.00 minimum are accepted

From \$2,500 to \$5000.00 - bids of \$250.00 minimum are accepted

From \$5,000.00 on up - bids of \$500.00 minimum are accepted.

## **Pre-Auction Estimates**

Buyer acknowledges that Surf Legends LLC., its agents and employees, shall be held harmless from any damage claims sustained during this period. This relationship/transaction does not constitute bailment.

### **Terms of Sale**

- 1. There shall be no guarantees nor warranties, express or implied. Each lot will be sold "as is, where is". The Bidder agrees that he has satisfied himself as to the acceptability of the lot(s) and is not relying on the Surf Legends liable for any representations.
- 2. Surf Legends may, at any time, at their sole discretion and without notice or liability to the seller or bidder withdraw or cancel the sale of any lot.
- 3. A purchaser is deemed to have accepted a lot when they make a bid.
- 4. Every person at the Auction Site before, during and after the auction sale shall be deemed to be there at their own risk with notice of the condition of the premises, and the activities on the premises and the conduct of third parties, and the Bidder shall so advise his agents and employees who attend the auction as their representative. No person shall have any claim, demands or causes of action, whether at law or in equity, against the Auctioneers, Surf Legends, LLC, or Mike Miggs personally or against their respective agents, employees or principals for any

injuries sustained or for damages incurred or for loss of property which may occur from any cause whatsoever.

- 5. The Purchaser/winning Bidder is solely responsible for the safe and timely pick-up and removal or shipping of any item(s) they may win at this auction.

Any unclaimed property remaining after the conclusion of the auction for which formal shipping arrangements have not been made will be assessed a \$100 rental fee per item payable prior to the item being released. However, if the item is not retrieved and/or formal shipping arrangements are not made and paid for within thirty (30) days of the auction, the property will be considered abandoned and forfeited and considered to be a donation to Surf Legends, LLC and Surf Legends LLC will have no further responsibility to the purchaser to return the item or pay for the same.
